OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The JC Toys Free Doll Sweepstakes (the Sweepstakes) begins at 10:00 AM Eastern Time (ET) on June 15, 2011, and ends when the JC Toys Facebook Page reaches 10,000 Likes. ("Promotion Period").

ELIGIBILITY: To participate in this Sweepstakes, you must be a legal resident of the 50 United States, the District of Columbia, or Canada and be at least 18 years of age at time of entry.

HOW TO ENTER: To enter the Contest, visit the JC Toys Page at www.facebook.com/jctoys click on the welcome tab, and complete the online entry form in its entirety and accepting the terms of the Official Rules, and submit (the "Entry").

DURATION: This Sweepstakes begins at 10:00 AM Eastern Time ("ET") on June 15, 2011, and ends when the JC Toys Facebook Page reaches 10,000 Likes. For an entry to be eligible, it must be registered within this time period. The entry period will be divided into "milestones," or in other words, each time the JC Toys Facebook fanbase increases by 500, starting with the first 1,000. Only one entry per person, address or e-mail address is permitted over duration of sweepstakes.
